





Trash Bash 2026

Thank you for your interest in participating in the **2026 Trash Bash Countywide Clean-Up**. Please review the following information carefully to ensure your group is prepared for this year's event.

1. Registration and Team Information

- The **contact person** listed on your sign-up sheet should be someone who can communicate details and updates to all group members.
- Each team will be assigned a **two-mile stretch of roadway** to clean **both sides**. If your group is interested in covering additional mileage, note that on your sign-up sheet.
- Roads will be assigned on a first-come, first-served basis. No new roads will be added in 2026—so sign up early!
- Roads will not be assigned until both the sign-up sheet and all Release of Liability forms are received. No
 exceptions.
- Please indicate the **nearest town or township** to help us assign an area close to you, if available.
- List **each participant's t-shirt size** on the form. (Available in youth and adult sizes up to 4X; no extras will be ordered.)
- **Team limit:** 6 people, including the driver.

2. Release of Liability

- Every participant, including the driver, must complete a separate Release of Liability form.
- For minors, a **parent or guardian** must also sign the release.
- Submit the original forms to: Darke County Solid Waste District 684 Wagner Ave, Suite C Greenville, OH 45331
- Originals are required to participate on April 25-26, 2026.

3. Supply Pick-Up

Supplies will be distributed at the **Ohio Center, Darke County Fairgrounds** during the following times:

- Friday, April 24, 2026: 3:00 PM 5:00 PM
- Saturday, April 25, 2026: 8:00 AM 9:30 AM

At least one representative from each team must attend to pick up supplies and receive final instructions. *Note: No materials will be distributed before April 24, 2026.*

4. Key Dates

- Entry & Form Deadline: March 13, 2026 (No exceptions)
- Clean-Up Dates: April 25–26, 2026
- Final Close-Out & Payment Deadline: July 31, 2026

5. Payment Information

- Teams will earn \$100 for each completed two-mile stretch (both sides of the road).
- Funds must be paid to a Darke County non-profit organization.
- Approximately **\$20,000** will be awarded to local groups through this program.
- To receive payment, two items are required:
 - 1. **Completed W-9 Form** for the Darke County Auditor *(only required for new participants)*.
 - 2. **Close-Out and Sworn Statement Form**, provided in your supply packet. This form documents the number of bags collected for our report to the Ohio EPA.
- Payments will be processed once all required information is received.

6. Safety Reminder

Your safety is our top priority. If something cannot be done safely—**do not do it**. **Safety first, trash last!**
