

APPENDIX B Recycling Infrastructure Inventory

The Village of Versailles provides waste collection and curbside recycling services to all the residents of the village and to commercial establishments. The commingled materials are collected separately from waste. The Village transports and markets the materials and reports the amount recycled annually.

Arcanum Village recycling service was provided by Bestway in the reference year 2018. Bestway did not report the amount of recycling collected. In 2020, the Village negotiated a new contract with Rumpke. The amount of household recyclables collected in 2021 from Arcanum will be included in the District total recycling from curbside collection and from drop-offs reported by Rumpke.

recycling reported by Rumpke for 2018 is included in the *Table B-7 Inventory of Material Handling Facilities Used in the Reference Year* total. Rumpke reported all of the Res/Com recycling as a total amount from all of Rumpke's recycling services in the District. The amounts for individual programs and locations is not available to the District.

Greenville City waste collection, recycling, and yard waste collection were provided by Rumpke in the reference year. Through a contract with the city, Rumpke is the only hauler that provides residential waste service to single and multi-family dwellings that use individual collection services. Individual households must sign-up with Rumpke for service and pay Rumpke directly. The vast majority of residents use the cart waste collection service and therefore automatically have curbside recycling service. There is an option designed for households that do not generate as much waste to purchase bags at local stores. The marked bags can be used to set out smaller amounts of waste. These households can also set out recycling. Although most households in Greenville subscribe, the District does not have access to the number of households that have regular cart service. The program, therefore, does not meet the technical definition of non-subscription curbside.

Palestine Village waste collection and recycling services were provided by Rumpke in the reference year through an agreement with the village. The arrangement is like that of Greenville, but there is not a per bag option.

Adams, Brown (part), Butler, Franklin, Greenville, Harrison, Jackson (part), Liberty, Monroe, Neave, Richland, Twin, Van Buren, Washington and Wayne (part) Townships: Rumpke Waste and Recycling automatically provides curbside multi-material recycling to households in the listed townships that subscribe to waste collection service. The District does not have access to the number of households served. However, other indicators like the amount of waste taken to transfer facilities and landfills used by Rumpke as compared to that delivered by other service providers serving these townships, supports the observation that the majority of households subscribe with Rumpke for waste collection services and therefore are automatically offered the opportunity for curbside recycling.

Rumpke Recycling and Transfer Facility provides a multi material drop-off box at the Rumpke Transfer Facility on Jaysville -St. Johns Road on the outskirts of Greenville. It is open during transfer station business hours which is at least 44 hours per week. Materials collected are listed in Table B-2a. The drop-off serves the Greenville City and Greenville Township area and is used by people bringing waste to the transfer facility from all over the county. Rumpke is responsible for this drop-off. The District benefits from the availability of this drop-off which is convenient for area residents and businesses.

This table has been omitted. Greenville is the only urban area in Darke County. In the reference year there were District sponsored drop-off containers located at two school sites in Greenville, at St. Mary’s School and Anthony Wayne Early Child Education Center. These sites are paid for by the District and

are primarily used by the schools in conjunction with school recycling programs. However, they are also used by the general public. The sites were not advertised as available drop-off sites in the reference year, so they are not included as urban drop-offs.

Note 2: Rumpke is the private hauler providing service to all the drop-offs listed in Table B - 2c. The amount collected from the drop-offs is included in the *Table B-7 Inventory of Material Handling Facilities Used in the Reference Year*. Rumpke reported all of the Res/Com recycling as a total amount for all of Rumpke's recycling services in the District. The amounts for individual programs and locations is not available to the District.

The drop-offs are provided by the District and are serviced by Rumpke. The sites have one or more 8-yard bins which are compatible with the trucks used for pick up. The sites are placed in locations where they are easy to access and also can be monitored to reduce the chances of litter and illegal dumping. The bins include signs that clearly state the materials that are and are not accepted. Most of the sites have two bins which are emptied weekly. Heavily used sites may be emptied twice in a week.

Table B-2d: Inventory of Part-Time, Rural Drop-off Sites Available in the Reference Year – Omitted

In the reference year there were no rural drop-offs that fit the definition of part-time rural drop-off sites.

There were 6 county school districts where 6- or 8-yard drop-off containers were placed. These sites are paid for by the SWM District and are primarily used by the schools in conjunction with school recycling programs. Most are also available to the public and the materials collected are the same as the other drop-off sites. However, these sites were not advertised as available drop-off sites for the public. Therefore, these sites are not included as Rural Drop-offs. The locations are Ansonia, Versailles, Arcanum-Butler Schools, Franklin Monroe Schools (Pittsburg), and Tri-Village Schools (New Madison), and Mississinawa. These and other school drop-off sites will be described in more detail later in the Plan.
